
FINANCE PROFESSIONALS BREAKFAST SESSION

Background

However, it is our collective responsibility to engage the stakeholders and provide the ideal opportunities to be part of the future of our beloved country. We cannot effectively participate in development without coming together as a cohort and set new strategic directions.

The mission of this breakfast session is to bring together accountants, auditors, and economist, regulators and business leaders to embraces challenges, share knowledge and opportunities relating to the future of our profession in the country. We want to inspire young people who are interested in the profession. The session also intended to set a blueprint for the future conferences in the country through the Gambia Institute of Chartered Accountants (GICA).

Session 1: Complying with the Gambia Tax Requirements

If you think about it very well, you will realise tax is one element that is always part of business transactions and is a major income stream for government. Tax is a legal requirement, and every company and individual must comply with it.

Non-compliance with tax requirements can have serious consequences for any organisation. This includes heavy financial penalties that could lead to court cases and often closure of the organization. It is therefore important for accountants, CEO and auditors to ensure that their business complies with the tax rules. Furthermore, tax systems can be complex and also changes over time.

This session will address the following areas:

- Common taxes in the Gambia including updated tax rates in 2018
- How businesses can comply with the taxes in the Gambia and avoid fines
- The cost of non-compliance with tax regulations
- The importance of tax compliance

However, audit practice evolves as businesses introduce products, structures and technology. This will help them improve their knowledge and skills to serve the stakeholders better.
